Terms & Conditions

BOOKING & CONFIRMATION

- A deposit is required to secure your booking. The amount will be deducted from the final balance.
- Final numbers and menu selections must be confirmed 7 days prior to the event.

PAYMENT

- Full payment is required 48 hours before the event. Payments can be made via credit card, EFT, or cash.
- Any additional charges incurred on the day must be settled prior to departure.

CANCELLATIONS

- Cancellations made more than 30 days before the event will receive a full refund of the deposit.
- Cancellations within 30 days will forfeit the deposit. Cancellations within 7 days may incur additional charges.

MINIMUM SPEND

- Minimum spend requirements apply to all private function bookings, especially on weekends. Any shortfall in the minimum spend will be charged as a room hire fee.

DIETARY REQUIREMENTS

- Dietary requirements must be advised at least 7 days prior to the event. While we endeavor to accommodate all needs, we cannot guarantee that our food is allergen-free.

VENUE HIRE

- Venue hire fees apply for evening functions and for events that do not meet the minimum spend. These fees are non-refundable.

DAMAGE & CONDUCT

- The client is responsible for any damage caused by guests during the event. Growling Frog Golf Course reserves the right to charge for repairs or replacement costs.
- Management reserves the right to refuse service or entry to any guest who behaves inappropriately.

EVENT TIMING
